



## COVID-19 Waiver of Liability Agreement

For the 2021-2022 school year

To enter the premises at ALLEGRO BALLET ACADEMY and to participate in instruction (hereinafter the "Activity or Activities"), I, on behalf of myself and any minor child/children for whom I have the capacity to contract, acknowledge and agree to the following:

1. I understand the hazards of the coronavirus (COVID-19) and am familiar with the Centers for Disease Control and Prevention (CDC) guidelines. I understand that COVID-19-related conditions fluctuate, and that, accordingly, the CDC guidelines are regularly updated. I accept full responsibility for familiarizing myself and complying with the most recent updates at all times while on the premises. I acknowledge that I have been advised about the precautions being taken by ALLEGRO BALLET ACADEMY, and am satisfied with the same.
2. I hereby acknowledge and fully assume the risk of illness or death related to COVID-19 arising from my or minor child's presence on the premises and participation in the Activities. On behalf of myself and minor children, I hereby RELEASE, WAIVE, DISCHARGE, AND COVENANT NOT TO SUE ALLEGRO BALLET ACADEMY, its owners and employees (the RELEASEES) from any liability related to COVID-19 that might occur as a result my or minor child's presence on the premises and participation in the Activities.
3. I agree to indemnify, defend and hold harmless the RELEASEES from and against any and all claims, demands, suits, judgments, losses or expenses of any nature whatsoever (including, without limitation, attorneys' fees, costs and disbursements), arising from or out of, or relating to, directly or indirectly, the infection of COVID-19 or any other illness or injury related to it.
4. It is my express intent that this Waiver Agreement shall bind my personal representatives. This Agreement and the provisions contained herein shall be construed, interpreted and controlled according to the laws of the Commonwealth of Pennsylvania. I HEREBY KNOWINGLY AND VOLUNTARILY WAIVE ANY RIGHT TO A JURY TRIAL OF ANY DISPUTE ARISING IN CONNECTION WITH THIS AGREEMENT. I ACKNOWLEDGE THAT THIS WAIVER WAS EXPRESSLY NEGOTIATED AND IS A MATERIAL INDUCEMENT FOR THE PERMISSION GRANTED BY RELEASEES TO BE ON PREMISES AND PARTICIPATE IN THE ACTIVITIES.

In signing this Agreement, I acknowledge and represent that I have read and fully understand the foregoing Waiver of Liability Agreement; that I am signing it voluntarily as my own free act and deed; that no oral representations, statements, or inducements, apart from the foregoing written agreement, have been made; that I am at least eighteen (18) years of age and fully competent; and that I am executing this Agreement for full, adequate and complete consideration, fully intending to be bound by same.
